We are working together to raise successful athletes to the highest level of competitive cheer, but also developing young leaders of good character and strong ethics. Tribe has grown to be one of the best training programs and most successful cheer programs in Oklahoma, and the nation, since we opened our doors in 2001!

Our staff is trained and brought up as superior cheerleading coaches, with an emphasis on training values larger in life than just cheer and to inspire each individual athlete they work with.

### **WHAT WE DO**

Tribe Cheer provides four different programs for all ages and skill levels: Fully competitive Elite cheerleading teams, competitive Prep teams, recreational class training programs, and private individual training. Our Competitive teams are a one year commitment.

### **PREP AND NOVICE TEAMS**

Tribe Cheer offers a 1 day a week All-Star Prep and Novice program. It is designed to encompass all the fun, values, and skills that are focused on in our All-star cheer program. All-Star Prep and Novice come with a shorter amount of training time per week and is a less expensive alternative for beginners, experienced level 1, and some level 2 athletes. The prep program is a great starting step in a cheerleader's experience. Prep & Novice teams typically stay in state for competitions, competing in OKC & Tulsa. A travel trip is offered once a season. Novice starts at age 3!

### **PREMIER PREP TEAMS**

This is Tribe's new program that provides the next stepping stone before being on an Elite team. This will encompass all the values as in the Elite program and continue to build skills throughout the season. Premier Prep will practice twice a week with a tumbling class built into one of their practices. Premiere Prep does require elite level standing and running tumbling. These teams will be local (including Tulsa), as well as 1/2 travel team.

### **ELITE TEAMS**

This program requires a more intensive practice and competition schedule, but is still skill and team focused. Our All-Star teams are highly competitive in an up-beat encouraging yet disciplined structured environment. These teams practice twice a week and travel multiple times a season for national competitions. We try to limit the out of state competitions to save money on hotel & travel. Tribe does try to offer a destination experience that is fun for the whole family at the end of the season.

# **ANNUAL REGISTRATION FORM**

By signing this document, you are waiving certain legal rights.  
Please read this document carefully before signing.

## **RELEASE, WAIVER AND INDEMNITY**

I, \_\_\_\_\_, ("Releasor") the parent or legal guardian of the above named student hereafter referred to as ("Athlete") do hereby permit the Athlete to participate in programs, competitions, gymnastics, tumbling, cheerleading or any other physical activities while an athlete at Tribe Cheer (TC Family LLC). By granting permission for "athlete" to participate in programs at Tribe Cheer, I assume full responsibility for "athlete's" personal safety and release Tribe Cheer, its supervisors and employees from any and all liabilities that may arise due to any injury including death to "athlete" by reason of "athlete's" participation in any activity at Tribe Cheer or in which Tribe Cheer is participating elsewhere.

In consideration of "Athlete" being permitted by Tribe Cheer to participate in the above activities, Releasor agrees to the following terms and conditions:

I understand there is personal risk involved in any activity that involves motion, height or rotation and that these activities can result in serious injury, disability or death.

I declare "Athlete" has been seen by a physician and is cleared to participate in physical activities such as gymnastics, cheerleading and tumbling.

I authorize Tribe Cheer to use photographs, video and/or other likenesses of "Athlete" for use in Tribe Cheer promotional materials or sales and waive any rights of compensation or ownership thereto.

I understand the first month's tuition will be required to be paid in full when registering for activities at Tribe Cheer. I understand that I must give written notice on or before the 5th day of the month, one month prior to dropping any class/activity at Tribe Cheer. Furthermore, I understand that if I do not provide Tribe Cheer this notice in writing, that my child is taking up a reserved spot in a tumbling class. I will not get refunded any charges that occur because my child just quit showing up without proper notice.

I understand Tribe Cheer does not refund or transfer tuition for any reason.

I understand there is a **QUITTER'S Fee of \$500** to quit once placed on a competitive team. This will change the whole overall plan for the team once the athletes have been added to teams based on their certain position. If quitting or removal from team falls 14 days before a performance event, the required buyout fee will be \$750 owed on the day of quitting or removal.

I understand that my bill must be paid in full before trying out for a new season team, and must continue to be paid in full each month. My athlete may be removed from the team for non-payment, and charged the \$500 QUITTERS Fee. There will be NO REFUNDS if removed from the team for any reason.

***I understand that I am responsible for the \$45.00 annual registration fee which will be automatically billed to my account in November 5th.***

# PAYMENT POLICY

I understand I am required to keep a current credit card on file with Tribe Cheer (TC FAMILY LLC), and that I am required to complete a credit card authorization form. If my credit card on file expires or I wish to place a different card on the file it is my responsibility to do so before the 6th day of the month.

All charges at Tribe Cheer are billed on or about the 1st day of each month and become due immediately. Customers have until the 5th day of each month to pay the balance due on their account via cash, check, etc. **All amounts remaining due on the 6th day of the month will be charged in full to the credit card on file.** If the 6th falls on a non-business day, then the card on file will be charged on the next business day. If the card on file is not able to be charged for the full amount or is declined, there will be a \$50 late fee added to your account. The athlete(s) associated with the account may be withheld from participating in activities at Tribe Cheer.

***I understand any check/payment returned unpaid for any reason will incur a \$35.00 return fee and a \$50.00 late fee. In the case that fake (fraudulent) numbers are changed or entered causing a decline we will charge double the late fee and take all necessary legal and collections actions.***

**RELEASOR HEREBY FULLY RELEASES AND FOREVER DISCHARGES.** Tribe Cheer and each of their directors, officers, employees, agents, representatives and insurers, of and from any and all liability to Releasor for any damage to or loss of Student or Releasor's property, injury or death arising directly or indirectly out of Athlete's participation in programs, activities or use of Tribe Cheer's facilities, **INCLUDING ANY SUCH DAMAGE OR LOSS THAT IS CAUSED BY ANY ACT OR OMISSION ON THE PART OF TRIBE CHEER, WHETHER OR NOT SUCH DAMAGE OR LOSS ARE CAUSED OR CONTRIBUTED TO BY THE SOLE, GROSS OR CONCURRENT NEGLIGENCE, OMISSION, STRICT LIABILITY, WILLFUL MISCONDUCT OR FAULT OF TRIBE CHEER AND WHETHER OR NOT CAUSED BY A PRE-EXISTING CONDITION.**
